THE APG GUNSMITH STUDENT SCHOLARSHIP SWEEPSTAKES ("SWEEPSTAKES") BEGINS AT 12:00 AM EASTERN TIME ("ET") ON 9/3/19 and ENDS AT 11:59 PM ET ON 12/31/19 ("ENTRY PERIOD").

ELIGIBILITY: Open only to legal residents of the 50 United States and the District of Columbia, age 21 years or older at time of entry and who can legally possess a firearm. Subject to all applicable federal and state and local laws and regulations. Void where prohibited by law.
